BOD Report- Jeff A General Manager written report.

- Rain in the week of 4/26/2021 caused the city sewers to flood the facility. There was no damage to the CSO office, however there was some water in the Region's part of the office.
- Working on getting another intercom system.
- There is a serious need for qualified Board members. Darlene B. resigned from the BOD, and new qualified members are needed. Flyer has gone out. One board member was voted into BOD prematurely, as she had not yet done enough service hours, Per the BOD Guidelines pg. 7 (Board Pool members must complete 10 hours of service at the CSO office, volunteer as needed and serve on Board projects, sub-committees or the office.)
